- 3.3 For Module 5 (Performing II)/Paper 4B, the basic requirement of this module was recommended to be changed from Grade 6 to Grade 5 practical examination of the Associated Board of ABRSM, etc.
- 3.4 For Module 3 (Creating I)/Paper 3, it was recommended to provide options as follows:

Option 1: two compositions with 1 free composition and 1 composition based on a brief, e.g. skills on composition

Option 2: 2 free compositions

3.5 For Module 6 (Creating II)/Paper 4C, a pool of repertoire might be provided or a particular style might be specified. Further discussion would be needed to iron out the details.
